Acceptable Documents include:

Bank or credit card statement	
Paycheck, paystubs or employment records	A vehicle liability card, binder or bill issued by an <u>IDAHO-BASED</u> carrier
Idaho school enrollment records or student ID (no college ID)	
Motel, hotel, campground or RV park receipt showing 30 days of residency	
Military Leave and Earning Statement (LES) to evidence Idaho residency of applicant deployed outside of Idaho while serving on active duty	
Relief Agency or Shelter Certificate	
Property Owner Residency Affidavit	

The Residential address you supply must be a street or highway address. It may not be a post office box. In areas where a number and street name have not been assigned, an address convention used by the U.S. postal Service is acceptable.

Documents must display the applicant's name and principal Idaho residence address. If electronic copies are presented (phone, iPad etc.), they must be printed off and scanned to the applicant's record.
